



PRESEASON EQUIPMENT INSPECTION REBATE FORM

⚙️ PROGRAM DETAILS

Registered members of the BOSS Owners Group are eligible to receive a **\$50 Rebate On Preseason Equipment Inspection Services** during the **8/11/2025-10/17/25** rebate offer period. The rebate offer is valid on each BOSS product that is inspected as long as the product is registered to the BOSS Owners Group member and the service is performed at an authorized BOSS Dealer (**only one form needs to be submitted**). The rebate is limited to 12 units per owner. If the BOSS Owner is the owner of a snow removal company, the check will be issued to the company name. See a complete listing of qualifications below.

⚙️ QUALIFICATION DETAILS

1. The equipment inspection must be completed by an authorized BOSS Snowplow Dealer. A listing of dealers can be found here: **bossplow.com/locator**.
2. The equipment inspection must take place between **8/11/2025-10/17/2025**.
3. To qualify for this rebate, you must be a registered member of the BOSS OWNERS GROUP and provide your valid BOSS OWNERS GROUP ID# on the rebate form. (Your ID# can be found on your My BOSS profile page.)
4. To be eligible, we must receive your completed rebate form and invoice by **October 31st, 2025**.
5. Rebate is valid in the United States (funds payable via a check in U.S. Currency only).
6. Rebates received after the October 31st deadline will not be processed.
7. **Rebate limited to 12 units per owner/company.**
